Top MBA Universities in Canada

Eligibility Criteria

The eligibility criteria to study MBA in Canada for Indian students is as follows

Every university in Canada which offers MBA program have their own specific detailed admission criteria and these universities can also have their own requirements.

 \cdot The student must have completed his/her undergraduate degree of 4 years with Graduate Management Admission test (GMAT) score.

· Considerable work experience.

• For international applicants, whose primary education language is other than English, an IELTS or TOEFL is necessary.

Canadian MBA schools generally require a **GMAT score of 550**. If it is less then it may be compensated by considering different factors of the student like career aspirations, work experience, or the way of presentation of a student in front of admissions committee.

Total Fees Structure for MBA Course The cost of studying MBA in Canada is quite higher and it can go up to **CAD \$30,000 - \$40,000**. In most of the famous MBA schools, the fees for international students are higher than the fees for the local Canadian students.

• If the budget of students is less than **\$20000 (Rs. 10,60,000)** then they can go for Dalhousie University, HEC Montreal, Carleton University and Memorial University of Newfoundland where they can get the admission in their budget.

• The universities like Cape Breton University, the Royal Military College, Laurentian University, Vancouver Island University and Schulich School Business at York University provide MBA education to students in **CAD \$20000 to \$30000** (between Rs. 10,60,000 - Rs.15,90,000).

• The universities like University of Alberta, Sauder school of business at University of British Columbia, etc. demand for around **CAD \$30000 to \$45000** (between Rs.15,90,000 - Rs. 23,85,000) for their MBA courses.

•The best MBA schools in Canada like Rotman school of management at the University of Toronto, Richard Ivey school of business at university of western ontario cost over **CAD \$60000** (Rs. 31,80,000) for 1 year.
