### HEALTHCARE PROFESSIONALS REQUIREMENT Report of European Commission

The European Commission, in its Staff Working Document on an Action Plan for the EU Health Workforce, estimates that without further measures to meet these challenges, a potential shortfall of around 1 million health care workers will take place by 2020-21.

## MALTA :: BOTTLENECK PROBLEMS IN HEALTHCARE A Study on Healthcare Workers Shortage

"The planned future expansion of the health care service by the government (e.g. the new Hospital Oncology Centre) is likely to absorb many of the new graduates in health. This is likely to increase the size of the bottleneck in the presence of a constant supply of professionals. Moreover, as is the case in many EU countries, Malta is confronted with increased demand for such services, due to an ageing population. Evidence suggests that the situation has been improving in recent years for doctors as the government adopted a series of measures to stop the outflow of talents and managed to attract foreign students. As far as nurses and midwives are concerned, the recent removal of the cap on the number of students admitted to the courses, a shortening of its duration and the improvement of contract conditions (including incentives for those who opt to return) only represent a first step. A "bridging" programme together with simplified recruiting practices are being used.""

## NURSING IN MALTA 6 Months Adaptation Course

PROGRAM INFORMATION	
Program: Nursing Course & Training	Program Module
Eligibility:	1)Practical Training in Health Care & Nursing
A) B. Sc. (Nursing)     B) Working Knowledge of English     C) Experience is desirable but not essential	for 6 months.  2)Candidates will have classroom sessions as well as hospital training during the Program

- Selection will be done through Screening Test & Interview.
- IELTS not required but Students should have good Knowledge of English.
- After 6 Months Course, Students will work as Nurse / Midwife in Hospitals in Malta.
- Candidates can further pursue education for improvement in financial and educaitonal standards.

## NURSING IN MALTA Program & Remuneration Structure

#### Germany Option:

- Candidates will joint Practical Work within 2 Months of Start of Course.
- Nurses will receive Stipend of Euro 600-Euro 650 Per Month during this period.
- After completion of 6 Months Course, the Nurses will be placed in Hospitals / Healthcare facilities and Nurse / Midwife in MALTA with starting Salary of <u>Euro 1400-Euro 1500</u> Per Month.
- Final Salary will depend on experience and skill of the Nurses, and experienced Nurses can start with initial salary of Euro 2000 Per Month after completion of the Course.
- Candidates will be eligible to apply for Nursing Job anywhere in Europe after the Adaptation course.
