

# Top courses to study in Australia

## 1. Business Management (MBA)

Thousands of international students choose to study a management course in Australia. It can have two options :- 1) Studying a general management course or the master of business administration. There are a number of management courses and good management schools in Australia.

### Some Benefits of Completing an MBA (Management Course) in Australia

- 1. MBA or management in Australia is recognized globally. It is of **very high quality** and it can improve a student's career path anywhere in the world. In Australia, there are more than 75 globally accredited internationally recognized MBA programs.
- 2. Management courses in Australia are best examples of **theoretical and practical knowledge** and they focus on development of student's personal skills, communication skills, and leadership skills. The Australian courses encourage students to think creatively and independently.
- 3. International students can get the **opportunity of an internship** or to complete an international exchange or study tour by which they can gain a very good experience.
- 4. In Australia, students can meet other students who are from many different cultures and thus it can give them a broad cultural perspective on management.

#### Eligibility Criteria

#### **The eligibility criteria to study Business Management in Australia for Indian students is as follows**

- A student must be an Indian.
- A student must be at least 18 years of age on 31st December of that particular year with good health.
- A student must have completed 10+2 years of education for an entry into a graduate(Bachelor) course.
- A student must be proficient in English language. If not then to prove language proficiency, he /she will need to qualify IELTS or TOEFL exam with good scores.

- For studying a Master's degree in Business management or MBA, applicant must have completed a degree equivalent to an Australian degree or graduate diploma or graduate certificate with a minimum 65 percent average credit score from a tertiary institution.
- All the 3 years bachelor's degrees from India are equivalent to Australian Bachelor's degrees and hence they are accepted in almost all the Australian universities. Some universities may demand for 16 years of formal education which means courses which have 4 years duration like B.E., B.Tech. etc. are needed.

### **Total Fees Structure for Business Management Course**

The course duration for bachelors in business management courses can be of **4 years**. The different colleges which offer bachelor's or master's degrees in business management are University of western Australia, university of Melbourne, Monash university, Australian national university, University of New South Wales, The university of Sydney etc.

The fees for business management courses are different at different universities. They can range from Rs.15 - 20 Lac Per Annum. Also the living cost for a student is around **Rs.13 - 15 Lac Per Year**. Thus, the total expense to study a business management course at an Australian university goes up to 95 lac for 4 years.

## **2. Accounting**

The subject which provides updates on the financial health of the company is known as Accountancy.

### **Some of the Reasons Why Students Should Study Accounting in Australia-**

- 1. To teach accountancy in Australia, the state of the art technology available in the field of Accountancy is used.
- 2. Students get a chance to learn from highly qualified and experienced accounting educators with different backgrounds.

- 3. Various disciplines can be explored by international students so that they can understand the practices in the other parts of the world also.
- 4. Australia has 3 professional accounting bodies, CPA Australia, Institute of Chartered Accountants and Institute of Public Accountants. If a student completes an accredited degree from a well known university or institute then it is the recognized pathway to associate membership to CPA Australia and Institute of Chartered Accountants
- 5. This field provides a lot of job opportunities to students like :- Taxation officers, Bankers, Entrepreneurs, Forensic accountants, Investment managers, Auditors, Traders, Financial advisors etc.
- 6. This field opens a door to the large number of job opportunities. So, there will be no shortage of accountancy job vacancies in near future for the students. So this gives job security to students.
- 7. The need for accounting graduates will be there always and that too globally.
- 8. As accountancy professional are needed in any industry.

Eligibility Criteria

**The eligibility criteria to study Accounting in Australia for Indian students is as follows :-**

- A student must be an Indian.
- A student should have Physics -Chemistry-Maths at 10+2 level in Science stream. That is, a student must have completed minimum 12 years of schooling.
- Students should be proficient in English language. If not they need to prove their language proficiency by giving exams like IELTS or TOEFL and scoring to a required extent.
- If a student wants to apply for the post graduate course then he/she should have relevant work experience.

### **Total Fees for Study Accounting in Australia-**

The bachelor in accounting course is of the **duration 3 years**. The fees for the bachelor course in Accounting in Australia is in between **Rs.12,75,000 to Rs.15,30,000 Per Year**. Thus, it would cost around Rs.38 to 46 Lac for the total course. If other living expenses are added to the above cost then it would cost around Rs.1 to 1.2 Cr.

Similarly, the fees for the Master's in Accounting course are Rs.11 to 16 Lac for one year. Thus, the total fees for the duration of 1.5 to 2 years would be in between Rs.16 to 25 Lacs. Adding other living expenses etc. the total cost of a masters course in Accounting will be around Rs.35- 55 Lacs.
